

**Informative notice for the EVENT PARTICIPANTS and consent for the PROCESSING
OF PERSONAL DATA in relation to the event
“Kuehne+Nagel Nola Hub Grand Opening” – Nola (NA), October 5, 2026**

**Privacy Informative notice on the processing of personal data pursuant to Article 13 of the
"Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the
protection of natural persons with regard to the processing of personal data" ("GDPR").**

Dear Participant,

*Thank you for attending our event! Protecting your personal data is very important to us.
In this regard, Kuehne+Nagel srl (Data Controller) would like to inform you about the purposes and means by
which your personal data are processed*

Purpose of the processing and nature of the main data processed.

We process your personal data for the following purposes:

1. Administrative purposes, related to the registration of participants in the event;
2. Security purposes, related to the control of participants' access to the physical premises or digital environments where the event is held;
3. Multimedia communication purposes of the event related to the publication of photos and video footage associated with the name on the internet or social media.

The personal data processed fall into the category of personal data, contact data, data relating to the *job title* and organizational position, personal images in static or moving format.

Legal basis for the processing

The legal basis for the processing of your personal data for the purposes set out above is

- the **Legitimate Interest of the Data Controller** with regard to the **purposes referred to in points no. 1 and no. 2** above, pursuant to Article 6 1) letter f) of the GDPR
- **the consent** of the data subject for the **purposes referred to in point no. 3** above, pursuant to Article 6 1) letter a) of the GDPR

Failure to provide consent to the processing for the purposes referred to in point no. 3 above, implies the impossibility of participating in the event for organizational reasons, as it is excessively difficult for the Data Controller to process the aforementioned data in different ways depending on whether or not the participant has given his or her consent.

Period of validity of Consent

This letter of consent will expire 5 years after the date of signing or earlier if, for example, the personal data is no longer necessary to achieve the purpose for which it was collected or following any revocation or objection.

Communication or dissemination of processed data

We do not disclose your personal data to third parties for purposes other than those highlighted above.
We do not disclose your personal data for purposes other than those highlighted above.

External service providers and data processors

For the organisation and management of the event, Kuehne+Nagel srl may engage external service providers that will process personal data exclusively on its behalf and in accordance with its instructions. Such providers will be appointed as data processors pursuant to art. 28 GDPR and will have access to personal data only to the extent necessary to perform the activities entrusted to them.

Information and exercise of the rights of the Data Subject to processing

We would like to inform you of the rights that the GDPR gives you, as a data subject. These rights are set out in Art. 13 of the GDPR and concern:

1. the right of the data subject to request access to personal data from the data controller;
2. the right of the data subject to request from the Data Controller the rectification or erasure of personal data or the restriction of processing. With reference to art. 7 of the GDPR, the data subject may revoke the consent given in relation to purpose no. 3 above at any time. The revocation of consent will result in the cessation of all activities by the Data Controller of publication and disclosure of images (videos and photographs) that see a recognizable portrait of the Data Subject. It should be noted that the withdrawal of consent does not affect the lawfulness of the processing prior to the revocation itself;
3. the right of the data subject to object to the processing of personal data;
4. the right of the data subject to data portability;
5. the right of the data subject to lodge a complaint with a supervisory authority.

Data Controller
